AGREED ORDER

BACKGROUND AND FACTUAL FINDINGS

- 1. The Department of Financial Institutions ("DFI") is responsible for regulating deferred deposit service businesses doing business in Kentucky in accordance with the provisions of KRS Chapter 286.9-010, et seq. (the "Act").
- 2. Advance-U-Cash, Inc. has a store in Florence, Kentucky. (License # 114-1)
- 3. Pursuant to the Act, the DFI conducted an examination of the store on April 30, 2012 to determine whether the activities of Advance-U-Cash, Inc. were in compliance with applicable laws and regulations; whether the practices and policies of Advance-U-Cash had a potential adverse impact on prospective borrowers; and whether the business was being operated efficiently, fairly and in the public interest.
- 4. During the examination, the DFI discovered that Advance-U-Cash, Inc. did not enter a customer's social security number correctly in the database and as a result the customer was able to obtain deferred deposit loan proceeds in excess of \$500.

STATUTORY AUTHORITY

5. Pursuant to KRS 286.9-140(1), a licensee shall accurately and promptly submit a customer's social security number in the database prior to entering into a deferred deposit transaction.

6. Pursuant to KRS 286.9-991, the Commissioner may assess a fine of not less than one thousand dollars (\$1,000) nor more than five thousand dollars (\$5,000) per violation, plus the state's costs for the examination, investigation, and prosecution of the matter, including reasonable attorney's fees and court costs against any person that violates any provision of the Act or accompanying regulations.

LEGAL CONCLUSIONS

7. Advance-U-Cash, Inc., violated KRS 286.9-140(1) by performing the acts set forth in paragraph 4.

AGREEMENT

- 8. In the interest of economically and efficiently resolving the violation described herein, the parties agree as follows:
- a. Advance-U-Cash, Inc. agrees to pay a fine assessment in the amount of one thousand dollars (\$1,000). The payment shall be in the form of certified check or money order payable to "Kentucky State Treasurer" and mailed to the Department of Financial Institutions, Attn: William Owsley, 1025 Capital Center Drive, Suite 200, Frankfort, KY 40601.
- 9. Advance-U-Cash, Inc. waives its right to demand a hearing, at which Advance-U-Cash, Inc. would be entitled to legal representation, to confront and cross examine witnesses for the Department of Financial Institutions, and to present evidence on its own behalf, or to otherwise appeal or set this Order aside.
- 10. Advance-U-Cash consents to and acknowledges the jurisdiction of the DFI over this matter and that this Agreed Order is a matter of public record and may be disseminated as such.
- 11. In consideration of the execution of this Agreed Oder, Advance-U-Cash, Inc., for itself, and for its successors and assigns, hereby releases and forever discharges the Commonwealth of

Kentucky, the DFI, Office of Legal Services, and each of their members, agents and employees in their individual capacities, from any and all manner of actions, causes of actions, suits, debts, judgments, executions, claims and demands whatsoever, known and unknown, in law or equity, that Advance-U-Cash, Inc. ever had, now has, may have or claim to have against any or all of the persons or entities named in this paragraph arising out of or by reason of this investigation, this disciplinary action, this settlement or its administration.

- 12. By signing below, the parties acknowledge that they have read the foregoing Agreed Order, know and understand its contents, and that they are authorized to enter into and executed this Agreed Order and legally bind their respective parties.
- 13. This Agreed Order shall constitute the Final Order in this matter.
