**Financial Institutions Joins Experts to Present on Financial Scams**  
*65 seniors armed with knowledge to fight fraud*

**Frankfort, Ky.** (Nov. 22, 2023) – Knowledge is power when it comes to identifying and fighting financial scams. Fraud experts recently equipped 65 senior citizens in Owensboro, Ky. with the very knowledge needed to avoid serious and detrimental scams. Called the Owensboro Senior Scam Jam, this one-day event opened conversations about a topic that is often difficult to discuss and understand. The Department of Financial Institutions (DFI) joined the event, furthering its mission to encourage sound financial decisions through education and empowerment.

DFI's information officer, Tasha Stewart, presented on "*Recognizing and Avoiding the Top Financial Scams*." Stewart included information about investment, romance, and technical support scams which, according to the most [recent data from the IC3](#), are the top three scams impacting Kentucky's elders. Additionally, the presentation focused on:

- General warning signs that a scam is taking place.
- How victims can protect themselves against scams.
- How victims can report scams to regulatory agencies such as DFI.

"If just one person avoids a scam after attending this event, then it was a success," said Stewart, who noted the scam jam was a judgement-free space for seniors to openly ask questions. "I heard from many people who had real-life fraud examples that impacted them, their family, or their friends." DFI will use the information gathered from Owensboro seniors to further support the fight against bad actors.

The information learned at these events also impacts the greater community by word of mouth. "An attendee will share some information they learned with their friends and before you know, the entire community is talking about ways to avoid scams. It's a win-win," continued Stewart.

Attendees also heard presentations on mail fraud, identity theft, and cybercrime. Free lunch, door prizes, an adaptive exercise break, and a bluegrass music intermission were included throughout the day. DFI would like to thank AARP Kentucky for hosting and their collaboration on the event.
