



# OLDEST BROKERAGE FIRM IN KENTUCKY

J.J.B. HILLIARD, W.L. LYONS, INC.



The present-day regional brokerage house, Hilliard Lyons, resulted from the 1965 merger of Kentucky's two oldest investment firms – Louisville based J.J.B. Hilliard & Son and W.L. Lyons & Co. The Hilliard company was the successor of A.D. Hunt and Co., which started in 1872 with John James Byron Hilliard as a partner. The Lyons company was an outgrowth of Quigley & Lyons which was founded in 1854.

A.D. Hunt and Co. originated as a private bank whose business included not only the ordinary transactions of a bank of deposit, but also the negotiation of investment loans and the handling of investment securities. When Hunt was dissolved and J.J.B. Hilliard took over, he continued the investment business of the earlier firm. Hilliard established a reputation for conservatism by specializing in government, municipal, and corporation bonds, and the highest grade investment stocks. Hilliard's son, Isaac, who joined the firm in 1902, bought a seat on the New York Stock Exchange in 1924. After that time,


the firm began to open branch offices throughout Kentucky, beginning with an Owensboro branch in 1945.

W.L. Lyons was instrumental in the creation of the Louisville Stock Exchange, which opened for business on March 15, 1905. He served as its first

president and purchased the first security offered on the Exchange, a \$1,000 Rochester Railway bond. This exchange was formed because even though the local

brokerage houses conducted business on the New York Stock Exchange through correspondent firms tied by telegraph, communications lacked immediacy and were costly. Creating a regional exchange allowed the Louisville brokerage firms to ascertain promptly what securities each of the other firms had to sell or buy and at what price. This ultimately inured to the benefit of the brokerage customer.

At the time of the 1965 merger, the two firms together had 13 offices in Kentucky and Indiana and 42 registered representatives. Combined they had a total of 150 employees. Shortly after the merger, the new firm installed a computer, the first brokerage house in Louisville to do so. This

step was all important in insuring the firm's survival during the stock market explosion that occurred in 1966. At the time, the firm was already trying to cope with a massive bookkeeping overload brought on by the merger in addition to trading volume unseen since before the 1929 crash. During this period, many other firms collapsed because they could not keep up with a trading volume that reached over 10 million shares per day.

After the merger, Hilliard Lyons began to expand its operations beyond Kentucky and Southern Indiana to become a regional powerhouse by the mid-1980s with offices

in ten states. The firm also launched efforts to energize its investment advisory operations. This area had become the fastest growing part of the company by 1980. Within a five-year period, the rapidly growing investment advisory department had \$150 million under five portfolio managers—up from \$35 million in 1974. Another growth area was established in 1983 when the Hilliard Lyons Trust Company received its charter from the Kentucky Department of Financial Institutions (then called the Department of Banking and Securities). At the time, it was the only trust company in the Commonwealth not affiliated with a bank. Like the investment advisory department, the trust company experienced phenomenal growth, in part because of its management's

emphasis on investment management over administration.

Another significant change occurred in the structure of the firm when the partnership incorporated in 1972. Initially, the former partners owned the corporation but ownership was substantially broadened over time to include key personnel and other up-and-coming qualified producers and staff. The decision to offer stock to employees is credited with helping to maintain the firm's competitive edge by retaining good people who had a stake in the continued success of the business.

In 1997, Hilliard Lyons determined that its next strategic move should be to seek out prospective buyers of the firm in light of extensive consolidation in the financial services industry that continues today. The firm found a partner in PNC Bank Corp and the two entities approved the acquisition transaction on August 20 1998. PNC offered Hilliard Lyons the resources to continue investing in high-tech equipment and services and an expanded client base. At the time of the acquisition, Hilliard Lyons had over 1,200 employees in 12 states throughout the South and Midwest. Since then, Hilliard Lyons has retained its name and employees along with its headquarters in downtown Louisville.

# FORMATION OF REGULATORY AGENCY

## DEPARTMENT OF FINANCIAL INSTITUTIONS

The Department of Financial Institutions was established by the Banking Act of 1912 as the Department of Banking. It was charged "with the enforcement of all laws heretofore passed, or which may be passed, relating to banks, trust companies, savings banks, combined bank and trust companies, organized and doing business under the laws of the Commonwealth of Kentucky." (Chapter 4, Section 1, Acts of the General Assembly of 1912.)

Within a few years, however, other regulatory responsibilities were added as the state's economy and its financial services needs evolved.

The legislature mandated supervision of state-chartered savings [building] and loan associations to the department in 1918 and added state-chartered credit unions in 1922. When oversight of the state's securities industry was given to the department in mid-1932, the agency was renamed the *Department of Banking and Securities*.

Consumer and industrial loan companies were added to the list of agency-regulated industries in 1946. With passage of the Sale of Checks Act of 1966, the legislature also required companies that sell money orders to become licensed through the department.

The department's scope was further expanded to include mortgage loan companies and mortgage loan brokers in 1980.

The department experienced a number of changes as a result of the 1984 General Assembly, which re-codified the Credit Union Act, overhauled the state's banking and credit union laws, changed the agency's name to the *Department of Financial Institutions* and established the *Financial Institutions Board*.

The Board is an advisory body comprised of 11 representatives from the respective financial services industries and the general public along with the Commissioner who serves as its chair.

Through the Check Cashing Services Act of 1992, the legislature gave the department the responsibility for licensing check cashing (a/k/a deferred deposit) companies. The department assumed additional regulatory authority in 1998 when field examiners were assigned to conduct on-site inspections of these entities.

## ORGANIZATION:

The **Commissioner** is the chief executive of the department and is responsible for implementing departmental policies, statutory mandates, and administrative regulations as well as for supervising the agency's day-to-day operations. The **Office of the Commissioner** also includes the **Office of General Counsel**, which handles the agency's legal affairs.

Ella D. Robinson, who had served as the agency's Deputy Commissioner for several years, assumed leadership of the department in December 1999 when Governor Paul Patton appointed her as its thirty-third Commissioner. In addition to the Office of the Commissioner and General

Counsel, the Department is organized along functional lines into three divisions: **Financial Institutions**, **Securities**, and **Administrative Services**.


- ✎ The **Division of Financial Institutions** is organized into three, industry-specific branches: *Banks*, *Credit Unions*, and *Compliance* and is responsible for chartering and/or licensing, examining, and otherwise supervising the operations of state-regulated depository and non-depository financial institutions.
- ✎ Similarly, the **Division of Securities** is organized into two branches: *Compliance and Enforcement*, which handle the regulation and supervision of the state's securities industry by registering, licensing, examining, investigating, and otherwise supervising securities offerings, as well as securities firms and professionals operating in Kentucky and/or involving Kentucky investors.
- ✎ The **Division of Administrative Services** is also organized into two branches: *Administrative Services and Technology*. As their names suggest, these branches are responsible for providing administrative (fiscal, training, operational, etc.) and technical (information systems) support services to the entire staff. The *Administrative Services Branch* is also responsible for layout and design of agency publications and assists in coordinating and supporting the agency's participation in trade shows, job/career fairs, town meetings, forums, and other media events.

The Department of Financial Institutions is one of 13 agencies within the Cabinet for Public Protection and Regulation and is totally self-funded. Revenues are derived from fees charged for assessments, examinations, call reports, applications, investigations, registrations, and licensing of state-chartered financial institutions and securities offerings and entities.



- ▶ To improve employee skills and professional development opportunities.




The old Capitol.

# LEGISLATION AND REGULATION

In 2000, the Department was successful in having legislation (Senate Bill 169) enacted into law that should provide the state's banks greater flexibility and reduce administrative compliance costs while the Department retains sufficient oversight capability. Among other things, Senate Bill 169 amended KRS Chapter 287 to provide state banks with CAMEL ratings of 1 or 2 the authority to engage in any banking activity that the bank could engage in if it were operating as a national bank or operating as certain designated financial institutions in any other state. In addition, Senate Bill 169 gives banks, designated by the Department, the authority to establish branches or relocate principal offices or branches without applying to the Commissioner for permission. The Department promulgated an administrative regulation (808 KAR 1:150) to set forth the criteria that banks must meet in order to act without Commissioner approval. Finally, Senate Bill 169 provides that the Department may accept any application or other required document in electronic format or in any other technology acceptable to the Department.

The Department's housekeeping legislation (House Bill 621) was also enacted into law and affected numerous amendments to the Consumer Loan statutes (KRS Chapter 288), the Credit Union statutes (KRS Chapter 290), the Industrial Loan Company statutes (KRS Chapter 291) and the Securities statutes (KRS Chapter 292). In addition to numerous technical amendments, House Bill 621 made the following changes: (i) allows for an alternative fee on consumer installment loan defaults; (ii) increases the amount that a credit union can loan to certain credit union officers,

directors and employees without approval of the board of directors and increases the amount of capital that a credit union can invest in shares of other credit unions; (iii) requires industrial loan companies to file an annual report with the Commissioner before January 30 of each year; and (iv) authorizes the Commissioner to exempt certain investment advisers from the statutory restrictions on investment advisory contracts with respect to certain investors.

The Department's Division of Securities also implemented several substantive

changes to its administrative regulations during the year. 808 KAR 10:030, relating to the conduct of broker-dealers, agents, employees, investment advisers and representatives, was amended to provide specific requirements for a broker-dealer to perform in order to effectively supervise an agent, to require written supervisory procedures that are reasonably designed to detect and prevent violations, to require investment advisers to provide a written disclosure statement prior to entering into a binding contract, and to clarify the Department's policy with respect to multiple registration of broker-dealer agents and investment adviser agents. 808 KAR 10:040, relating to dishonest or unethical practices, was amended to provide additional examples of dishonest and unethical practices by broker-dealer agents, issuer agents, investment advisers and investment adviser representatives. Finally, 808 KAR 10:340, relating to the registration exemption for certain limited offerings to accredited investors, was amended to correct a statutory reference.

# DIVISION OF ADMINISTRATIVE SERVICES

## DIVISION OF ADMINISTRATIVE SERVICES

The Division of Administrative Services is headed by a division director and is comprised of two branches: Administrative Services and Technology. Employees in this division work closely with the Commissioner and her staff to provide administrative and technological (information systems) support to all department staff and to manage the agency's public information and media relation endeavors.

## ADMINISTRATIVE SERVICES BRANCH

Employees in the Administrative Services Branch provide administrative support to the department in the following areas:

- Ø Facilities management: Frankfort office and district offices in Eddyville, Bowling Green, Louisville, and Lexington;
- Ø Fiscal management;
- Ø Operations and quality control;
- Ø Records management;
- Ø Agency publications; and
- Ø Staff development: coordinating Employee Training & Continuing Education and Examiner Certification programs.

A primary agency goal is to hire, train, and maintain a highly informed and capable staff. One of the ways the Department seeks to accomplish this goal is through staff development by identifying training needs, developing and delivering agency-specific training, coordinating and/or sharing training and education resources with other state and federal agencies, and assuring equal access to continuing education and training opportunities for all employees.

Through continued innovation and open communication, the Department is hopeful that its past accomplishments will carry forward into the future and will enable this agency to become second to none in terms of staff development through training, continuing education, and career development opportunities. As the following table illustrates, such staff development was clearly an agency priority during the year 2000.

In addition to staff training, the Administrative Services Branch continued to coordinate and support the agency's efforts to inform/educate consumers, legislators, and industry representatives. While the Department has been seeking ways to improve its public outreach and consumer education efforts in recent years, the agency realized a substantial increase in public relations initiatives either launched or expanded during the year 2000. For example, the Department published and distributed newsletters focusing on issues relevant to the following financial services industries: MONEY MATTER\$ (regulatory news for Kentucky's state-chartered banks), DFI SPY for CREDIT UNION\$ (regulatory news for Kentucky's state-chartered credit unions), and COMPLIANCE CONNECTION (regulatory news for each licensee in Kentucky's mortgage loan, small loan company, industrial loan company, and check-cashing industries). A newsletter focusing on the Department's regulation of Kentucky's securities industry is scheduled for publication in 2001. The Administrative Services Branch, was also instrumental in developing and publishing several more informational brochures and for once again distributing copies of its Annual Report to the state's public libraries and to senior citizens' centers across the Commonwealth.

Staff members from throughout the agency continued to enhance the agency's visibility by participating in public education forums, town meetings, and industry association meetings. The Department's presence at career days and job fairs was further increased during 2000 as Administrative Services staff visited in high schools and colleges in central

and south-central Kentucky and spoke with students about job opportunities with the Department. Administrative Services employees also represented DFI at the annual Governor's Diversity Day, a job fair that draws hundreds of students and teachers from across the state to Frankfort to learn about career opportunities in state government.

As it has for many years, the Department maintains a toll-free telephone number, and consumers and industry representatives wanting to speak with a member of the agency's staff are encouraged to call 1-800-223-2579 with their questions and concerns. ## TECHNOLOGY BRANCH

The Department of Financial Institutions (DFI) continues to take every appropriate step to further the effective use of Information Technology (IT) to improve the delivery of its services, not only to the financial services industries it regulates, but also to other state and federal government agencies and to the citizens of the Commonwealth.

The millennial event for which the Department had been preparing for several years came about without incident, as



Security and privacy issues continue to raise very real concerns across the country, and DFI is no exception. In addition to helping plan, design, and implement the agency's future IT needs, the Information Technology (IT) Branch provided ongoing technological support throughout the year 2000 to all of DFI's employees and was responsible for the Wide Area and Local Area Networks for the central office and for its four field offices.

# DIVISION OF FINANCIAL INSTITUTIONS

The Division of Financial Institutions is responsible for licensing, chartering and regulating the activities of state-chartered/licensed depository and non-depository financial institutions. The Division's duties are strategically divided among three branches: Bank, Credit Union, and Compliance.

During 2000, each branch began publishing an annual or bi-annual newsletter dealing with topics of interest to the industries regulated. Back issues of the newsletters are available on the Department's website at [www.dfi.state.ky.us](http://www.dfi.state.ky.us).

## EIGHTY-EIGHTH ANNUAL BANK AND THRIFT REPORT

The primary duties of the Bank Branch include the chartering and regulating of 180 state-chartered commercial banks, five independent trust companies, and one savings association, as well as numerous bank trust departments, bank holding companies, and electronic data processors. As of December 31, 2000, the banks held an aggregate in excess of \$29 billion in assets, while the savings association held slightly less than \$28 million in assets.

Effective risk management remains the most important characteristic of successful banks. However, risk areas such as electronic banking are receiving more and more attention as technological changes in how financial institutions conduct their business persist. Consequently, refinements to the Department's examination strategy, which focuses on various risk components, continued in 2000 as the agency was more attentive to problem and potentially problem institutions.

The year 2000 was a strong year for Kentucky's state-chartered banks in terms of financial performance. No banks failed, and the Department identified fewer than ten problem banks during the entire year. Through December 31, 2000, Kentucky banks enjoyed a healthy return on assets (ROA) of 1.30%, reflecting a slight increase from year-end 1999. At 9.45%, the core capital (leverage) ratio remained strong.

The Department of Financial Institutions granted five new charters in 2000 for a total of eighteen new charters since 1997. However, the Department expects the establishment of de novo banks to slow down in 2001, as capital has become harder to raise and market opportunities appear not to be as plentiful.

# SIXTY-SEVENTH ANNUAL CREDIT UNION REPORT

The Credit Union Branch supervises the activities of 44 Kentucky state-chartered credit unions, ranging in size from \$91,850 to \$449,364,992. The number of credit unions under supervision by this branch continues to decline, as consolidations remain prevalent in the industry.

Kentucky's state-chartered credit unions experienced another financially healthy year in 2000. Earnings remained stable and continued to provide for capital maintenance while capital ratios remained above national averages. A noticeable and somewhat disturbing trend was the increase in the Total Loans to Total Assets ratio, which was higher in 2000 than it had been in over the past five years. As a result of this increase, the Department's examiners have been scrutinizing the area of Asset/Liability Management more closely.

Aggregate assets grew at a rate of 6.66 percent, with December 31, 2000 totals exceeding \$957 million. Some of the growth is attributed to consolidations and expansions in credit unions' fields of membership. The Department of Financial Institutions approved three mergers during the year.

The National Credit Union Administration (NCUA) released a new examination system in 2000 for federal and state credit union examiners. Branch Manager Randy Duncan continues to serve as a member of the NCUA's Technology Development Group whose function is to assist in developing and testing new examination software.

# FOURTH ANNUAL COMPLIANCE REPORT

The Compliance Branch licenses and regulates mortgage brokers and companies, check cashers, consumer and industrial loan companies, and companies who sell money order (sale of checks). As of December 31, 2000, this branch supervised nearly 1,300 licensees in all categories.

While the number of consumer and industrial loan companies licenses have been stable, the Department has seen an explosion of licenses in the mortgage and check casher areas. The table below reflects the growth in these areas:

The primary reasons for the substantial increase in these licenses appear to be the overall favorable state and national economy experienced during this timeframe, coupled with the fact that these entities provide a service niche that other financial institutions have not met.

Examination initiatives for mortgage brokers/companies and check cashers continue to grow. A new examination program for mortgage entities became effective in 1998, with a total of 125 examinations conducted in 1998, 170 in 1999, and 180 in 2000. In addition, changes to Kentucky law governing check cashers became effective in April 1998, which required the branch to establish examination procedures consistent with the new law. A total of 137 examinations were conducted in 1998, 289 in 1999, and 342 in 2000 on the check cashing industry. Another 391 examinations were conducted on consumer and industrial loan companies in 2000.



# DIVISION OF SECURITIES

## SIXTEENTH ANNUAL SECURITIES REPORT

The Division of Securities regulates the activities of individuals and firms who sell or provide advice on securities to Kentucky residents. This regulation takes several forms – licensing of securities firms and professionals, registration of securities offerings, compliance with and enforcement of the Blue Sky Law, and the education of Kentucky investors.

During 2000, the number of securities firms and professionals licensed by the Division increased substantially, a likely result of the strong bull market. However, the end of the bull market during December of 2000 signaled an end to this record growth. Likewise, the number of securities offerings filed with the Division increased throughout the year.

Also during 2000, the Division saw an increase in the number of nontraditional securities products being offered to the general public – promissory notes, brokered CDs, viatical settlements, and customer-owned coin operated telephone systems, just to name a few. The sales activities related to these products often spurred investigations by the Division. A number of investigations resulted in orders entered by the Commissioner against firms and individuals for alleged violations of the Securities Act of Kentucky.

The year ended on a positive note as the Division initiated a comprehensive investor education program aimed at providing Kentuckians with the tools they need to make wise investment choices. Part of this program is dedicated to giving teachers materials they can use to help students learn responsible saving and investing habits. Through these efforts, the Division hopes to help shape a generation of savvy and informed investors who have the skills necessary to prosper financially.
