Comes now, the Commonwealth of Kentucky, by and through the Commissioner of the Department of Financial Institutions (“DFI”), and hereby enters this **Order Rescinding Emergency Order to Cease and Desist** and directing that the mortgage loan broker license of D & A Services, Inc. d/b/a First Premier Mortgage (“Respondent”) be reinstated.

Respondent was licensed as a mortgage loan broker in Kentucky pursuant to KRS Chapter 286.8. On March 2, 2010, DFI received a Notice of Cancellation or Nonrenewal (“Notice”) from Great American Insurance Company regarding the Respondent’s surety bond. The Notice stated that Respondent’s surety bond as a mortgage broker was cancelled for nonpayment of premium.

By letter dated March 3, 2010, DFI informed the Respondent that it had received the Notice from Great American Insurance Company and that the Respondent must show reinstatement of the bond or evidence of issuance of new bond on or before April 3, 2010.

Evidence of reinstatement of the bond or evidence of issuance of a new bond was not provided to DFI on or before April 3, 2010. Therefore, on June 30, 2010, DFI entered an

Emergency Order to Cease and Desist. The emergency order suspended Respondent's mortgage broker license in Kentucky and ordered the Respondent to immediately cease and desist from engaging in the mortgage loan process in Kentucky.


On July 7, 2010, the Respondent presented a surety bond from Western Surety Company effective June 7, 2010 to the DFI.

ORDER

Based on the foregoing, the Commissioner hereby **ORDERS** as follows:

1. The Respondent's Kentucky mortgage loan broker license is hereby **REINSTATED**; and
2. The **Emergency Order to Cease and Desist** entered June 30, 2010 is hereby **RESCINDED**;
