This matter is before the Commissioner of the Department of Financial Institutions ("DFI"), pursuant to KRS 13B.120. The Commissioner hereby enters this **Final Order**.

On October 18, 2011, a hearing was held in the above-styled matter. Shaun T. Orme appeared as counsel for the Department of Financial Institutions ("DFI"). Michael Dugan ("Respondent") did not appear and no one appeared on his behalf. On December 27, 2011, the Hearing Officer issued a Recommended Order of Default based on Respondent's failure to appear at the hearing. In the Recommended Order of Default, the Hearing Officer recommended that Respondent's mortgage loan originator registration be suspended and remain suspended until he demonstrates he meets the financial responsibility requirements of the law.

On January 6, 2012, Respondent timely filed exceptions to the Recommended Order of Default. Based on the exceptions filed, Respondent has demonstrated that he meets the requirements of KRS 286.8-255(9)(c) and 808 KAR 12:021 §5.

Having considered the record in this matter, the Recommended Order of Default, and the exceptions filed by the Respondent, and being sufficiently advised, I hereby Order that

Respondent's loan originator registration not be suspended. Specifically, the Respondent does meet the financial responsibility requirements of KRS 286.8-255(9)(c) and 808 KAR 12:021 §5.

FINAL ORDER

THEREFORE, it is hereby **ORDERED** that:

- 1. The Exceptions filed by the Respondent demonstrate that he meets the financial responsibility requirements of KRS 286.8-255(9)(c) and 808 KAR 12:021 §5; and
- 2. The mortgage loan originator registration of Respondent Michael Dugan SHALL NOT BE SUSPENDED.
