ORDER WITHDRAWING EMERGENCY ORDER OF SUSPENSION

Comes now the Commonwealth of Kentucky, by and through the Commissioner of the Department of Financial Institutions ("DFI"), and hereby enters this Order Withdrawing the Emergency Order of Suspension, suspending the mortgage loan broker license of the Respondent, MortgageTree Lending of Indiana LLC ("Respondent"):

- 1. Pursuant to KRS 286.08-140 (1), the Commissioner has the authority to exercise general supervision and control over mortgage loan companies and mortgage loan brokers doing business in the Commonwealth of Kentucky, which includes, among others, the power and duty to promulgate such orders as are deemed to be necessary and appropriate to accomplish the basic purposes of and provisions contained in KRS 286.8.
- 2. On August 20, 2024, the Commissioner entered an Emergency Order of Suspension in the above action, after Respondent failed to cooperate with examination request deadlines. According to the Order, "the mortgage broker license of Respondent, MortgageTree Lending of Indiana LLC, is **SUSPENDED** and shall remain suspended until this Order is rescinded by subsequent Order." Respondent subsequently responded to the examination requests, and the examiner for Department completed a Report of Examination dated September 19, 2024.

3. KRS 286.8-140 (2)(a)(2) grants the Commissioner the authority to rescind their orders from time to time when they find that the action is necessary and appropriate in the public interest and consistent with the purposes fairly intended by the policy and provisions of KRS Chapter 286.8.

4. Based on the standards in KRS 286.8-140, the Commissioner finds that withdrawal or rescission of the Commissioner's August 20, 2024, Emergency Order of Suspension is necessary and appropriate in the public interest and consistent with the purposes fairly intended by the policy and provisions of KRS Chapter 286.8.

Accordingly, IT IS SO ORDERED that the Commissioner's August 20, 2024, Emergency Order of Suspension heretofore entered against Respondent is WITHDRAWN/RESCINDED on this the 18th day of December, 2024.
