AGREED ORDER

BACKGROUND AND FACTUAL FINDINGS

1. RT Mortgage Corporation is licensed with the Department of Financial Institutions (“DFI”) as a mortgage loan broker whose principal office is located at 660 North University Boulevard, Second Floor, Middletown, Ohio 45042.
2. In November 2008, DFI discovered that Respondent was maintaining an unregistered branch location at 71 Cavalier Boulevard, Suite 309, Florence, Kentucky in violation of KRS 286.8-100.
3. On November 7, 2008, a DFI investigator discovered web listings for the unregistered branch. The DFI investigator also visited the branch where he observed Respondent’s signs, offices, office equipment, employees, and Kentucky loan files.

AGREEMENT AND ORDER

The Department of Financial Institutions and RT Mortgage Corporation, in the interest of economically and efficiently resolving the violations described in the foregoing Background and Factual Findings, agree as follows:


1. RT Mortgage Corporation agrees to pay a fine in the amount of one thousand dollars (\$1,000) for the violations set forth above, which shall be in the form of a certified check or money order made payable to “Kentucky State Treasurer” and mailed to the Department of Financial Institutions, Attn: Jessica Sharpe, 1025 Capital Center Drive, Suite 200, Frankfort, Kentucky 40601 prior to the entry of this Order.

2. RT Mortgage Corporation shall permanently cease and desist from conducting any Kentucky business from unregistered locations, including but not limited to the location identified herein, until such locations are properly registered as a branch location in accordance with the requirements set forth in KRS 286.8-100 and KRS 286.8-032(5).

3. In regard to this matter, RT Mortgage Corporation waives its right to demand a hearing, at which RT Mortgage Corporation would be entitled to legal representation, to confront and cross examine witnesses for the Department of Financial Institutions, and to present evidence on its own behalf, or to otherwise appeal or set aside this Order. Further, RT Mortgage Corporation consents to and acknowledges the jurisdiction of the Department of Financial Institutions over this matter and that this Agreement is a matter of public record and may be disseminated as such.

4. This Agreed Order shall constitute the Final Order in this matter.




