**ORDER VACATING FINAL ORDER
SUSPENDING MORTGAGE LOAN ORIGINATOR REGISTRATION**


Comes now, the Commonwealth of Kentucky, by and through the Commissioner of the Department of Financial Institutions (“DFI”), and hereby enters this **Order Vacating Final Order Suspending Mortgage Loan Originator Registration** that in effect rescinds the suspension status of Stephen Jones’ (“Respondent”) mortgage loan originator registration in Kentucky.

On August 1, 2011 Respondent’s mortgage loan originator registration was suspended for failure to comply the financial responsibility requirements of KRS 286.8-255(9)(c) and 808 KAR 12:021 §5. Subsequently, Respondent has provided information that demonstrates he now meets the requirements of KRS 286.8-255(9)(c) and 808 KAR 12:021 §5. Therefore, it is now appropriate to rescind the suspension of Respondent’s mortgage loan originator registration.

ORDER

Based on the foregoing, the Commissioner **hereby ORDERS** that the August 1, 2011 Final Order suspending Respondent's Kentucky mortgage loan originator registration is hereby **VACATED**.
