**AGREED ORDER**

**BACKGROUND AND FACTUAL FINDINGS**

1. TMG Real Estate and Financial Services, LLC d/b/a First Omni Mortgage Lending (“First Omni Mortgage Lending”) is licensed with the Department of Financial Institutions (“DFI”) as a mortgage loan company whose principal office is located at 310 West Liberty Street, Suite 100, Louisville, Kentucky 40202.

2. On January 28, 2008, an examination was conducted into the condition, workings and affairs of this location in order to determine whether: (1) it was in compliance with applicable laws and regulations; (2) its practices and policies had an adverse impact on prospective borrowers; and (3) it was being operated efficiently, fairly, and in the public interest.

3. In the course of that examination it was discovered that First Omni Mortgage Lending violated Chapter 286.8 of the Kentucky Revised Statutes by employing or using two (2) unregistered individuals to originate loans in Kentucky.

**AGREEMENT AND ORDER**


The Department of Financial Institutions and First Omni Mortgage Lending, in the interest of economically and efficiently resolving the violations described in the foregoing Background and Factual Findings, agree as follows:

1. First Omni Mortgage Lending agrees to pay a fine in the amount of four thousand dollars (\$4,000) for the violations set forth above, which shall be made payable to "Kentucky State Treasurer" and mailed to the Department of Financial Institutions, Attn: Jessica Sharpe, 1025 Capital Center Drive, Suite 200, Frankfort, Kentucky 40601.

2. In regard to this matter, First Omni Mortgage Lending waives its right to demand a hearing, at which First Omni Mortgage Lending would be entitled to legal representation, to confront and cross examine witnesses for the Department of Financial Institutions, and to present evidence on its own behalf. Further, First Omni Mortgage Lending consents to and acknowledges the jurisdiction of the Department of Financial Institutions over this matter and that this Agreement is a matter of public record and may be disseminated as such.

3. This Settlement Agreement shall constitute the Final Order in this matter.

STATEMENT OF AUTHORIZATION


